What is Title 1?

- Title I is a federal allocation of funds for schools classified as low income for the purpose of assisting students to demonstrate proficiency related to the State of Utah's academic standards.
- Title I is a federally funded program under the Every Student Succeeds Act (ESSA).



There are two types of Title 1 schools:

- 1) Targeted Assistance Schools
- 2) Schoolwide Assistance Schools

Spectrum Academy is classified as a Targeted Assistance Title 1 School.

What is the difference between Title I Targeted Assistance and Schoolwide Schools?

Targeted Assistance Schools:

- Use Title I funds only for supplementary educational services for eligible children.
- Identify as eligible those students who are failing or most at risk of failing to achieve state academic standards.
- Prioritize eligible students in rank order to provide services to those in greatest need.
- Establish staffing patterns and schedules of services to meet the needs of students.
- Minimize the removal of students from the regular classroom during classroom instructional time.
- Actively involve the classroom teacher in assessing individual student performance and planning additional services.

Schoolwide Assistance Schools:

- Create a plan that integrates schoolwide reform strategies.
- Are permitted to use funds from Title I to upgrade the entire educational program of the school in order to raise academic achievement for all students.
- Maintain a school-wide mission and goals that help all students achieve high standards.
- Are relieved of the requirement of identifying specific students for Title I services.
- Identify how other Federal and state funding sources are used to implement the school-wide plan.





A key element of the Title 1 program is parent involvement. There are six key leverage points for parent involvement in Title 1 that give parents the power to be effective partners with schools:

#1: Parent Involvement Policy

Every Title 1 school must have a written parent involvement policy, developed with and approved by parents.

#2: School-Parent Compact

Every Title 1 school must have a school compact, developed with parents, in order to help all children achieve high academic standards.

#3: School Policy

Every district and charter school must have a written Title 1 parent involvement policy that is developed with parents and evaluated every year.

#4: Report Cards

The school district must distribute a report card specifying how every school and the district as a whole are performing.

#5: Public School Choice

If a Title 1 school has not made adequate yearly progress (AYP) over the past two or more years, parents have choices.

#6: State Review

The state education agency is responsible for monitoring Title 1 programs in its state.
